She developed the school's 'Family Linkage' project that maps all family and kinship relationships within the school to support teachers and other staff members in understanding family relations and gaining greater cultural knowledge and awareness.

EO REPORT / 2019 ANNUAL GENERAL MEETING

On behalf of Gumala Aboriginal Corporation (GAC) Directors, I would like to thank all who were able to attend the Corporation's Annual General Meeting (AGM) and Consultation Meeting on Saturday 26 October 2019.

These meetings were held in South Hedland, home of the Karriyarra people. We thank them for welcoming and hosting Gumala people on their country.

For a Corporation of Gumala's size and diverse membership, successfully holding an AGM is no easy task. Directors and staff prepared and planned, for a number of months leading up to the event, to ensure that the day moved forward as smoothly as possible.

We also recognise that not all of our Members can attend AGMs for a number of reasons, particularly Members of the Gumala family who have experienced losses recently. The meeting observed a minute's silence to pay respect to each of your families – our thoughts are with you all.

For those of you unable to be at the AGM and consultation, the meetings saw approximately 460 Members and Beneficiaries registering to attend, with the total number of attendees on the day exceeding 550. This was a wonderful turnout.

AGMs are an important opportunity for Members to come and hear from the Board and management on the operations, challenges and successes that face the organisation.

It is also an opportunity for Members to give feedback directly to the Board on the issues that are important to them. On this note, the comments and concerns raised on the day will be actioned accordingly by the GAC Board.

At the 2019 AGM, each of the language groups elected two two-year appointments as only half of the Boards terms expired this year.

As a result, Mary Mills, Augustine Allen, Charles Smith, Nola Naylor, Layneisha Sgro and Natalie Parker were appointed for two years as Directors of the Corporation. The current Board is listed on page 3.

Additionally, GAC would like to thank Mr Steven Dhu and Mr Andrew Dhu, whose terms expired at the AGM, for their time and dedication as Directors of the Corporation.

Mr Steven Dhu was appointed at the 2015 AGM, holding various office bearing positions throughout his time on the Board. Mr Andrew Dhu was also appointed at the 2015 AGM and successfully filled his terms. We wish each of them well in their future endeavours.

Following the AGM, the Board met to discuss the appointment of office bearers. The Board has reconfirmed the appointments of Ms Gloria Smith as Chairperson and Ms Natalie Parker as Vice Chairperson, and has appointed Ms Pamela Condon as Secretary.





COMMUNITY DEVELOPMENT UPDATE







PEEDAMULLA STATION - HERITAGE HOMESTEAD @ JUNDARU

The homestead is located about 58 km south-east of Onslow and has the Cane River running through the property, the reason it has been given the Indigenous name Peedamulla, meaning plenty of water.

Many Gumala Members have worked on the station over the years in various roles like jackeroos, cooks, house staff and general hands.

One of the significant assets on the station, the homestead, is now a State Register Heritage site. It has been identified as a major refurbishment project by both the State Government Heritage Council and Gumala.

The initial project was the total refurbishment of one of the outer buildings which is now the reception office for the visitors to the camp ground.

Two stages have now been completed which have involved the removal of the hazardous materials on site, and the replacement of the roof trusses ready for sheeting. The trusses have been engineered to withstand the cyclones that impact on the region.





LORE @ WIRRILIMARRA

This will be the first Lore ceremony to be conducted for this period, November through March, of what possibly will be one of the busiest in years for the Yinhawangka, Nyayparli and Banjima families.

Other ceremonies are expected for Cane River and Wakuthuni, however these are yet to be confirmed.





The past few months have seen a hive of activity taking place in Wirrilimarra, including the ongoing maintenance of the community's assets and preparation for the conduct of Lore for up to 10 eligible young men.

The preparations have also included the refurbishment of the water supply to the Lore Community Camp Grounds for the several hundred families and community members expected to attend the opening.

The bough sheds were repaired and readied for occupation, as was some of the overflow accommodation in the community.

There were guest speakers from various academic institutions as well as some mainstream businesses. GEPL has submitted its Elevate RAP for review and approval of this process is near completion and will be available to Members early in the new year.

Employment

To date, GEPL has 20 Aboriginal employees (inclusive of three Directors) all from various language groups across WA and Australia. With the likelihood of the Great Northern Highway project commencing soon, GEPL is aiming to have over 30% Aboriginal employment by 30 November.

Current / Completed Projects

RTIO – West Angeles Deposit C & D Enabling Works

GEPL continued at WADCD Enabling works over the period and additional works have also been awarded to GEPL over period from the original contract scope. The project is due for completion in March 2020.

Main Roads Western Australia – Acciona Clough JV (ACJV) – Great Northern Highway (GNH) – Koodaideri Rail Bridge

In October GEPL was awarded the Koodaideri Rail Bridge subcontract for earthworks by ACJV. The works consist of clearing, topsoil strip, borrow pit establishment and material management, bulk & detailed earthworks.

RTIO – Tom Price Mine Site – NEBC Waste Dump Rehabilitation - Gumala / Downer JV

GEPL has entered into a 50/50 joint venture with Downer Mining and has been successful in the award of the NEBC waste dump rehabilitation project at Tom Price.

The North End Box Cut Waste Dump (NEBC) is a historic black shale waste dump approximately 80ha in area. NEBC requires the entire dump to be reshaped and encapsulated with inert material and the then a capping layer of competent waste applied to the batters.

RTIO - Paraburdoo - Rock Breaking Services

Work has continued at Paraburdoo consisting of rock breaking of oversize material at various locations within Paraburdoo mine site. The resized material will then be fed into the production circuit. The project is scheduled for completion in December 2019.

GIPL AGM well attended

Thank you to all of the Gumala Members and Beneficiaries who attended this year's GIPL AGM which was held in Kelmscott, Perth on Sunday 29 September.

Approximately 392 people registered for the event on the day, with the number of attendees well over 500.

The meeting was an opportunity for Chairman Brendon Grylls to thank outgoing Nyiyaparli Director Brad Hall for his valuable contribution to the GIPL Board. The recruitment process for the new Director is currently underway.

GGF Investments Update

The General Gumala Foundation wishes to advise Beneficiaries that as at 30 September June 2019 it had total assets under investment of \$140.5M, with the Future Fund valued at \$116.9M.

The investment portfolio has remained steady over the September quarter despite the impact of falling interest rates on various investments.

Going forward the Trust will be looking to shift more funds from cash investments into market investments and also look to leverage the investments to generate positive social impacts for Beneficiaries.

A Social Impact Investments Manager is expected to commence within the Trust in December to drive this agenda.

Total Revenue for the quarter to 30 September 2019 was \$5.5M with \$4.1M being retained for the benefit of Members and Beneficiaries through available Member Program Funding and Investments into the Future Fund.

The Trustee is pleased to see Gumala Members and Beneficiaries making use of the increased available programs provided by GAC, with funding for Member Programs of \$3.0M for the quarter based on applications processed and acquitted by GAC, compared to a total of \$6.3M for the entire prior financial year.
