Instead of carrying the meetings over two days, both GAC and GIPL held their AGMs on the same day after the morning Consultation Meeting.

Feedback following the AGM indicated that it was one of the best AGMs that Members have attended.

Once again Members were able to apply for an Advanced Payment of Travel Allowance and register electronically on arrival at the venue. Moving forward we hope to have more options around electronic voting and attendance online.

EXECUTIVE OFFICER REPORT

On behalf of Gumala Aboriginal C o r p o r a t i o n ' s Directors, I would like to thank all who were able to attend the Corporation's Annual General Meeting (AGM) and Consultation Meeting on Saturday 23 October 2021.

These meetings were held in South Hedland, home of the Kariyarra people and we thank them for welcoming and hosting Gumala people on their country. Thank you also to Kariyarra Elder Alfred Baker for providing the Welcome to Country.

The meeting saw approximately 766 Members and Beneficiaries register to. It was a big day for Gumala!

As a result of the elections, there were a few changes with our Directors, along with the changes in office bearers appointed. These updates can be seen on the back page of the newsletter.

A number of topics were covered at both the Consultation Meeting and the AGM. For those Members who were not able to attend the AGM, following is a summary from the day:

Joint Strategy and Foundation Review Update

The Consultation Meeting commenced with an update on the Joint Strategic Plan and a video, narrated by GIPL employee and Banjima Member Arleah Simpson, was played to provide Members and Beneficiaries with an overview of the contents of the plan.

The Boards of GAC and GIPL have been working closely

over the past 12 months on developing and finalising the strategic plan, which was endorsed by both Boards in September 2021. The 5-year and long-term goals included on this plan will guide Gumala moving forward.



Underpayments update and YLUA Modernisation

The GAC Board has been meeting frequently with Rio Tinto representatives over the past 6 months to progress with the negotiations.

At the AGM, some Members inquired about what aspects of the YLUA were being modernised and what was the scope for modernisation.

We can report that GAC has commenced negotiating a royalty model with RTIO which will be included in a modernised YLUA, however the royalty percentage is still be agreed. In terms of the scope of the modernisation, GAC is exploring all avenues of modernising the agreement, including in areas of the agreement that pertain to the protection of heritage and cultural sites, and access to resources such as water.

Some Members requested that in negotiations with RTIO, GAC considers negotiating for compensation to be paid based on contamination of land as well as ground disturbance/royalties.

Members also queried whether GAC should negotiate for Members to have shares in Rio Tinto, as this could be financially beneficial for Members, and could also allow them a role in decision making if they were to become shareholders of the company.

Members also emphasised the need to hold RTIO accountable for meeting Traditional Owner employment objectives as they are stated in the YLUA. Members agreed that these objectives should be tightened in the modernised YLUA.

Members noted that the Trust Deed will also require modernisation through the process of modernising the YLUA.

Gumala Enterprises Pty Ltd (GEPL) Update

An update on the GEPL Restructure and Karijini Eco Retreat (KER) was presented. Members expressed their dissatisfaction with the level of Traditional Owner involvement in the running of KER and felt that there has not been enough effort on GEPL's behalf to improve this KPI.

Some Members questioned whether GEPL can be used as a training facility/become involved in a work ready program supported by RTIO.

Housing Program Update

An overview on the Housing Support Program and some background information on Housing in the Pilbara was given, explaining that the lack of available and affordable housing in the Pilbara is a significant issue for Gumala Members. However, it was also stressed that there are long-term consequences for creating a housing program that alleviates the responsibility of the State Government for solving housing issues in the Pilbara. Many Members agreed that the Housing Support Program is important, but it is also important that Gumala continues to hold the State Government to account on these matters.

A portion of Members questioned whether the Housing Support Program would be available to Members who already own their homes and could utilise the program funds to pay off their mortgage or carry out renovations on an existing home.

At this stage of the program, the eligibility criteria only applies to those Members who need transitional housing, and down the track, new eligibility criteria can be developed to assist Members in a variety of housing circumstances.

It was recognised that the initial project won't address all sections of the Gumala family, but we need to start somewhere and build upon a pilot model. It was also noted that broadening of the program eligibility criteria is somewhat dependent on a good outcome from the underpayment negotiations.

2021 Christmas Program

Members were asked to vote on whether they would prefer GAC paid the \$500 Christmas Program amount as a cash payment instead of a gift card this year. The cash option is preferable for GAC as in previous years, providing gift cards has caused large administrative overheads which could be avoided if the program consisted of a cash payment instead of gift cards.

The Members cast a vote in favor of the 2021 Christmas Card Program consisting of 2 options where Members can either opt for a \$500 cash payment or a \$500 gift card. This Christmas Program has now been rolled out and payments will be made by Friday 17 December at the latest

COVID-19 VACCINATION HUB AT AGM

At Gumala's recent AGM, Dr Aleeta Fejo addressed the membership to talk about the importance of getting vaccinated against COVID-19.

Dr Fejo (pictured below right) is a member of the Australian Indigenous Doctors' Association (AIDA) and a senior GP with 35 years' experience in Aboriginal health.

The opportunity to get vaccinated was offered in a pop-up clinic run by health professionals, and Gumala is pleased to report that over 30 Members were vaccinated at the AGM, including Director Maurice Narrier (pictured right).

Gumala continues to encourage our Members who are not vaccinated to talk to their doctor or a health professional about any concerns they may have.

Unfortunately, the Pilbara region continues to see the lowest vaccination rates in Australia. Under the Government's mandatory COVID-19 vaccination policy, Gumala (having staff working in or entering remote Aboriginal communities) is required to have all staff fully vaccinated by 31 December 2021.

Through our Member Sponsorship Program, Gumala was pleased to recently contribute to the Harmony 9s Rugby League tournament held in Perth by providing shade marquees for players and supporters of Gur Wirimalpa.

Nyiyaparli man and Gumala Member Ratehi Hirini founded and manages Gur Wirimalpa; a state Aboriginal and Torres Strait Islander rugby league team he said he started to represent our nations based on the principle of acknowledging where we have come from, sharing culture through generations and embracing opportunities.

Ratehi said the name Gur Wirimalpa comes from both the Torres Strait – Eastern Islands language group and Nyiyaparli languages. Gur meaning Saltwater in Meriam Mir and Wirimalpa meaning Warrior in Nyiyaparli.

The tournament was played across two days in November, and 8 of the 29 players were from Port Hedland and travelled down for the event.

"We work hard to incorporate culture. We see we are more than a team; we are family. We work and support one another to ensure the sharing and preservation of culture and language by incorporating learning events in training," said Ratehi.

The team will look to travel and play other teams across Australia over the next year to help improve the love of rugby league for Aboriginal people in WA, including creating a women's and youth representative team. We wish them all the very best!

3A PLAYGROUP EARLY LEARING UPDATE



Gumala is thrilled to announce the opening of a new 3a Playgroup in South Hedland located at 18 Mooring Loop. The centre is open Monday to Friday from 9am to 11.30am for all Aboriginal families.

All families are welcome to join in and participate in our 3a Playgroups, with a brand new site open in Hedland 5 days a week.

We have lots of fun, exciting activities and play equipment for children 0-5 to engage in with their families.

Each of our playgroups use the 3a Approach (Abecedarian Approach Australia), which empowers families as their child's first teacher. This approach focusses on building children's oral language through fun learning games, conversational reading and enriched caregiving.




EMPLOYMENT & SKILLS DEVELOPMENT

COMMUNITY PROJECTS UPDATE

Bidiltha Projects

Donga Refurbishment

The Bidiltha community has been going full steam ahead with one of the dongas being completely refurbished.

The insides of the dongas have been gutted and fixed up, painted and had new fittings installed. The outside of the donga has a large fly shade shed extending over into a patio around the entire building.



Pacific Energy Solar Power System Installation

Gumala has partnered with Pacific Solar Power Energy Systems with the aim to create sustainable power options in all our Homeland communities.

In Wirrillimarra, the solar power system has been running for almost a year now. Bidiltha has just had the new solar system installed in November and we are very excited for the community.

The new solar system means that the community will be spending less money on fuel to run the generator and will ensure that that the community has a sustainable power source long into the future.





Mingullatharndo

The Mingullatharndo community has been busy with much-needed upgrades and maintenace work on a range of community buildings. These works included refurbishing the transportable dongas, artefact display room, tearoom and the woodwork workshop.

After a long wait, the solar power system is now up and running due to the purchase of the solar power batteries for the solar power system. Being able to access sustainable power will reduce the expensive fuel costs to the community.

Another exciting development is the water treatment plant that has been installed with the community accessing quality clean water.

All these projects have been possible due to the strong partnership between the Mingullatharndo community, Fortescue Metals Group and Gumala.

"We are so grateful and thankful to Gumala for all the support to make this all happen," said Marshall Smith.



Youngaleena Community Building Refurbishment

Throughout August and September 2021, the Youngaleena community building was refurbished to meet the needs in the community.

The community urgently required a space that was wheelchair friendly for all Members needing disability access and use of the facilities in the building.

This project meant that people with disabilities living in the community now have access to facilities that support social and emotional wellbeing and inclusiveness.

Thanks to their unwavering determination, they ensured that a land use deal would be struck that would result in long-term economic, social and community development benefits to the Traditional Owners.

In 2022 we look forward to celebrating this 25-year milestone with our membership.

We plan to come together to celebrate and showcase the many achievements of our Gumala Members through a special 25 Year Anniversary Celebration Event.

At the time of publication, the event is planned for early to mid-March and we hope to have more details out to our Members as soon as they are finalised.

GGF Financial Overview

The General Gumala Foundation Trust is pleased to advise the Beneficiaries that as at 30 September 2021, the total assets under investment were \$185.3M, with the Future Fund valued at \$157.5M. Within the Future Fund we hold Investments of \$145M.




The first quarter result has seen a solid start to the year from dividend and distribution returns, but at the same time market investment values have fluctuated with growth in July followed by subsequent reductions in August and September with an overall reduction of \$1.1M.

In the September quarter, the Trust commenced the purchase of houses in Karratha, which will be utilised, along with existing Trust houses in Tom Price and South Hedland, for the GAC Housing Support Program. As such, there was a continued significant reduction in residential property rental income compared to the previous year.





Total Revenue for the 3 months to 30 September 2021 was \$8.92M with \$7.29M being retained for the benefit of Members and Beneficiaries through available Member Program Funding and Investments into the Future Fund.




Within this total revenue, the Yandi Land Use Agreement payments totalled \$6.54M.



As of the 30 September 2021, the Gumala Foundation has spent a total of \$7.9M on program funding.



The allocated budget was \$8.7M. The amount spent on Health and Wellbeing was higher than budgeted, with the Foundation having spent \$4.3M. This is primarily due to the Flexible Program allowing greater choice for Members to better control their funding, with more Members using their funds for Health & Wellbeing in this quarter.
