My life in a nutshell; I got locked out of Western Australia last year with everything COVID-19, despite this, I managed to finish my Master degree at the Australian National University and finally I was able to come home in December, only to leave soon after to get my belongings on the East Coast and be locked out again. It's been quite unbelievable!

Trying to make the best out of the situation; I applied for the Oxford Women's Leadership Development Programme.

Given the global pandemic, this Programme took place completely online, with a large cohort of women across the world; it provided a space to critically examine, acknowledge, and develop my leadership style and skills.

## **EXECUTIVE OFFICER REPORT**



#### Thannarru,

You might recall that in February, the Corporation held its 2019-20 Annual General Meeting (AGM) which would have been held in October 2020 but was deferred due to the management requirements of COVID-19 and public gatherings.

Presently, the Corporation is preparing for the 2020-21 AGM on Saturday 23 October 2021 which will again be held in Port Hedland. We are again, holding the AGM in Port Hedland because Port Hedland is currently the only town in the Pilbara that can cater for the number of registered attendees that Gumala attracts.

However, we are in the process of reviewing our procedures to see how we can facilitate an AGM online or at different locations to encourage more Member participation.

This year, we will be giving updates on the following:

1. GGF Strategic Plan – The Boards of GAC, GIPL and GEPL have been working together to identify a broad strategy focused on the next 5 years and then the next 25 years. This has been done to bring about better alignment and identify strategies that should be represented throughout the three businesses.

- 2. Yandi Underpayments and YLUA Modernisation Progress these conversations are ongoing with the GAC Board holding strong on a fair settlement of the infrastructure underpayments and also a fair modernisation of the 25-year-old Yandi Land Use Agreement. While we hoped to have finalised these matters with Rio Tinto by October 2021, GAC is strong in its resolve to represent the interests of the Gumala people however long the process may take.
- 3. GEPL Restructure Gumala Enterprises no longer delivers civil and construction work but instead has been restructured to focus on and develop Karijini Eco Retreat and tourism opportunities for interested Members. It means that we are not competing with Member businesses that currently operate within civils and construction but provide opportunities to consolidate cultural tourism delivered by Members.
- 4. Housing Program Recognising the challenges of limited affordable housing within the Pilbara, Gumala has been working towards lessening the impact of our more vulnerable Members who are or could become homeless due to the rising rental prices. We recognise that the initial project won't address all sections of the Gumala family, but we need to start somewhere and build upon a pilot model.

More information and detail will be provided at the AGM and these will be delivered jointly by GAC, GIPL and GEPL who have been working closely with each other on each of items. This means we will only be impacting on one day of your weekend, but it means we all need to work together to share the information and get the business of the AGM done.

# **Gumala welcomes new 3a Coordinator Sheryl Hicks**

My name is Sheryl Hicks and I am the new 3a Program Coordinator for the Gumala Playgroups across the Pilbara.

I have been a teacher across the Pilbara region for the last 18 years and have also been the Deputy Principal of Wickham Primary School and recently the Principal of Tjuntjuntjara Remote Community School.

I am very excited to be working for Gumala, in partnership with the Department of Education, to support families to engage with our 3a sites which are open, at no cost, to all Aboriginal families in the communities we operate – Karratha, Roebourne, South Hedland, Marble Bar, Wakuthuni and North Tom Price.

Our playgroups encourage families to participate with their children from birth to four years of age and focus on building language through conversational reading and learning games, whilst encouraging enriched caregiving through establishing fun routines.

By participating in one of our 3a playgroups you will provide your child with a great start to their early years learning, and enhance their educational outcomes.


Prior to all this work being done, Gumala and Ashburton Aboriginal Corporations partnered to clean and clear out the 3a Learning Centre with the community.

### Thank you, Suzie





## **GUMALA INVESTMENTS PTY LTD (GIPL)**

#### **GGF Financial Overview**

The General Gumala Foundation Trust is pleased to present the quarterly update for June 2021 and advise the Beneficiaries that, as at 30 June 2021, assets under investment totalled \$175.2M, with the Future Fund valued at \$153.6M. Within the Future Fund we hold Investments of \$140M.



The full financial year has seen a strong positive rebound with growth in investment values, with an increase of \$19.4M against a decrease in 2020 of \$6.5M which was caused by the early impacts of the Covid-19 pandemic.

Actual investment earnings from interest, dividends and distributions, and rent, have increased slightly from 2020, with strong residential rent growth offsetting the impact of low interest rates.

The overall combined returns from earnings and values has seen the Future Fund increase by \$33.4M since 30 June 2020.



The Gumala Foundation received \$15.8M in revenue for the June quarter. This brings the total revenue for the 12 months to the 30 June 2021 up to \$42.5M. \$34.0M has been retained for the benefit of Members and Beneficiaries through available Member Program Funding and Investments into the Future Fund. Within this total revenue, the Yandi Land Use Agreement payments totalled \$37.1M, up from \$32.6M in 2020.-As of the 30 June 2021, the Gumala Foundation has spent a total of \$19.2M on program funding.

## MURDOCH'S CHIRO STUDENTS TREAT THE PILBARA



The annual placement of Murdoch University chiropractic students in Tom Price and Paraburdoo was once again supported by Gumala in 2021.

Each year since 2007, groups of chiropractic students and supervisors travel to the Pilbara to provide health assessments and hands-on care to community members and travellers.

This free service is eagerly anticipated by the locals each year when the students visit. Over the years, students have now provided around 20,000 health checks and treatment visits across the remote areas of WA. While the student chiropractors primarily see people with back pain and other physical problems, they also encourage healthy

living, and give advice that improves quality of life and wellbeing such as exercises and stretches.

The 10 students were again supervised by Dr Lyndon Amorin-Woods who was accompanied this year for the first time by local chiropractor Dr Mark Hooper who has practised in the Tom Price Medical Centre for over 7 years.

Prior to participation in the placement, students were required to complete cultural awareness courses to become more familiar with Indigenous culture. However, they were really interested in learning more about local culture and stories, and were most appreciative of the opportunity to have an immersive experience with Brendon Cook at the Wakuthuni community.

### 2022 EDUCATION PROGRAM OPENS SOON

Children of registered Members or Beneficiaries are eligible to access our Education Programs (Kindy – Year 12) for the 2022 school year from 1 November 2021 as the current 2021 school year program runs until 31 October. There has been a further balance increase in the education program moving forward.

The 2022 Education Programs provide the following amounts:

- \$500 per child for kindergarten students
- \$2,500 per child for primary school students
- \$4,000 per child for high school students

#### What items are available?

- 1. Books and stationery
- 2. School fees and contributions
- 3. Uniforms
- 4. Canteen lunches
- 5. Camp and Country Week fee

- 6. Equipment e.g. sports clothing, musical instrument, computer, iPad (only one per financial year)
- 7. School photographs
- 8. Tutoring
- 9. Travel & accommodation (boarding school and school bus services only)
- 10. Extracurricular activities or excursions
- 11. Bicycles and scooters. (capped at \$600)
- 12. Children's sports clothing (excluding uniforms; capped at \$600)

#### Eligibility

All school aged Gumala Beneficiaries (minors) are eligible for this program if:

- They are going to school (enrolment records may be required)
- Their parent is a registered Member of Gumala Aboriginal Corporation (pending Member's children cannot access funds).
